

Agreement to be Governed by Handbook Policies

Parents/Students agree to follow the policies and practices as described in the Sacred Heart School Parent/Student Handbook. The policies and procedures outlined in the handbook may be modified or amended at any time without notice, and nothing contained therein shall be deemed to constitute a contract with the school.

Tuition Policies:

To receive parishioner tuition rates, refer to the 'Sacred Heart School Guidelines to Qualify for Parishioner Tuition', in the Parent/Student Handbook.

Students may not begin a school year with delinquent tuition; families will be required to make arrangements for resolving any outstanding tuition PRIOR to a student being permitted to attend school in the new year.

All students are required to participate in student fundraisers. The fundraising fee is an obligation by participation in the Marathon \$130, \$70 generated from the 52 Club and a \$25 playground supervisory fee. Fundraising fees are due by April 15, 2011. After this date all unpaid fundraising amounts will become part of the tuition responsibility.

Withdrawals – Terms of Enrollment/Terms of Withdrawal of Enrollment - Sacred Heart School relies on its student enrollment as of July 10, 2010 for determining staffing requirements, for ordering textbooks and supplies and for planning purposes for the upcoming school year and for which Sacred Heart School has a financial obligation. The applicable tuition fee must be paid on or before July 10, 2010, according to the schools available payment options, to enroll the student for the coming school year.

If you terminate the students enrollment on or before July 10, 2010 you will have no financial obligation to the school and if you have paid any part of the tuition obligation it will be refunded to you in full.

If the student has been enrolled as of July 10, 2010 but the student enrollment is terminated for any reason after July 10, 2010, you will nevertheless be financially obligated to pay the entire year's tuition fee. No portion of the tuition that has been paid for which is due will not be refunded or canceled in the event of absence, withdrawal or dismissal from the school after July 10.

The School Advisory Committee approved the above policies. Only the principal or pastor can approve exceptions to these policies. If you cannot pay tuition on time, you must communicate with the principal.
